## DEER HUNTING (SHOTGUN SLUG ONLY) PERMIT

A permit is required by the city for the discharge of firearms for the purpose of hunting deer with a shotgun (slug only) in the Restricted Zone South. Refer to the City's Hunting Map for zone boundaries.

### **PERMIT REQUIREMENTS:**

1. Only landowners or immediate family members are eligible for this permit. Immediate family members are limited to the property owner's children, siblings, grandchildren and their respective spouses.
2. Written permission by the property owner shall be given to any person prior to the discharge of a firearm on his/her property.
3. A request for such permit shall be accompanied by written permission from fifty percent (50%) or more of the adjacent landowners on page 2 of this application.
4. Attach property owner consent forms and copy of state hunting license to this application.
5. Identify are of hunting by marking the map on page 3 of this application.
6. Permits shall be obtained from the city thirty days prior to opening day of firearm deer season, as established by the Minnesota Department of Natural Resources.

### **CONDITIONS OF ISSUANCE:**

1. Permit must be in possession of the hunter.
2. This permit shall only be issued under the terms consistent with City Code 5-4 and all applicable state and federal laws and regulations governing the hunting of deer via firearm and discharge of firearms shall occur no closer than one-quarter (1/4) mile from any urban development, park or institutional use.
3. Permit expires December 31<sup>st</sup> of the current year.


